The water treatment system was upgraded in 2010 to include cartridge filtration & ultra violet disinfection. As water is used throughout the distribution system, and the level of the water in the standpipe falls to a preset limit, a well pump starts. Groundwater is pumped through the cartridge filters, ultra violet disinfection units & then sodium hypochlorite is added. The water is directed through a feeder main to refill the standpipe.
