Describe your Drinking-Water System

Lansdowne's Drinking Water System consists of two groundwater water wells which are considered to be under the direct influence of surface water (GUDI). As such, the water treatment system was upgraded in 2010 to include cartridge filtration and an ultraviolet disinfection system. As water is used throughout the distribution system, and the water level in the standpipe falls to a preset limit, the duty well pump starts. Raw water from the well is pumped through two of three cartridge filter trains and then through one of two ultraviolet disinfection units. Sodium hypochlorite is added to provide secondary disinfection. The treated water is then directed through a feedermain to refill the standpipe.

Sodium hypochlorite was used at an average dosage rate of 2.64 mg/L.
