BY-LAW NUMBER 22-005

**BEING A BY-LAW TO AMEND BY-LAW 21-061, GENERAL-PURPOSE
BY-LAW TO ESTABLISH GENERAL RATES AND FEES FOR VARIOUS
SERVICES PROVIDED BY THE MUNICIPALITY**

WHEREAS Sections 9, 10, and 11 of the Municipal Act, 2001, S.O. 2001, c. 25 permits a municipality to pass by-laws.

AND WHEREAS Section 391 (1), Municipal Act, 2001, S.O. 2001, c.25, permits a municipality to impose fees and charges for services and activities provided.

AND WHEREAS Section 7(1) & (2) of the Building Code Act S.O. 1992 Chapter 23, as amended, authorizes the Council of a Municipality to enact a By-law establishing fees for the processing of applications made in respect of building matters provided that such fees shall be designed to meet only the anticipated reasonable direct and indirect costs to the Municipality to administer and enforce the Act;

AND WHEREAS Section 15.5 of the Building Code Act authorizes Council to set a fee for issuance of a certificate of compliance with the property standards by-law;

AND WHEREAS Section 69 of the Planning Act, 1990, as amended, authorizes the Council of a Municipality to enact a By-law establishing fees for the processing of applications for planning matters, including appeals to a local body under Section 8.1(8) and 45(3), provided that such fees shall be designed to meet only the anticipated costs to the Municipality to process said applications;

AND WHEREAS Section 69 of the Planning Act, 1990, as amended, provides that any person required to pay a fee for the processing of a planning application may pay the fee under protest and then appeal to the Ontario Municipal Board the levying of the fee or the amount of the fee by giving written notice to the Municipal Board within 30 days of payment of the fee;

AND WHEREAS pursuant to Section 69 of the Planning Act, 1990, as amended, Council or the Committee of Adjustment may reduce or waive an application fee or Ontario Municipal Board hearing costs where Council or the Committee of Adjustment is satisfied that it would be unreasonable to require payment in accordance with the tariff;

AND WHEREAS it is deemed desirable to establish a schedule of fees and charges for certain municipal services; and


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF LEEDS AND THE THOUSAND ISLANDS AMENDS BY-LAW 21-061 AS FOLLOWS:

1. **THAT SCHEDULE "A" Fees for General Licenses** be amended by changing the fee for Wrecking Yard -Annual License from \$550 to \$55 in the 2021 and 2022 columns of the by-law.
2. **THAT SCHEDULE "C" Fees for Building Permits** be amended by changing the fees for Heat Pump and Plumbing Permit from \$110 per \$1,000 of value, Minimum of \$140 to \$11 per \$1,000 of value in the 2021 and 2022 columns of the by-law.
3. **THAT SCHEDULE "I" Fees for Water and Sewer** be amended by changing the fee for Size- 1 1/2" or less, Water Consumption up to 15m³ in the 2021 fee Column from \$78.76 to \$77.68.
4. **THAT SCHEDULE "I" Fees for Water and Sewer** be amended by changing the fee for Size- 2" or Greater Water Consumption up to 15m³ in the 2021 fee Column from \$95.64 to \$94.32.
5. **THAT** the fees established by this By-law shall become effective upon the passing of this By-law.

Forfeit of Deposit

Deposits will be retained when a cancellation of a facility rental is not done within 72 hours of the scheduled booking or if the facility needs repairs or cleaning

Definitions

Event Rate: An event rate for a hall will allow for access at 3pm on the day prior to the event and allow for a clean up until noon of the following day

Weekend rate: A weekend rate for a meeting room will allow the renter to access the space for Saturday and Sunday, uninterrupted by the other rentals

Non-Profit: An organization that serves the community without the intention of monetary or material gain, all funds or goods attained through rentals will be put back into services for the community

Cleaning Charge: As the renter is expected to leave the space as it was found, the renter will be charged for any cleaning required beyond the regular janitorial schedule
